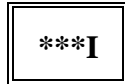

PROCEDURAL PAGE

The Commission proposals referred to on the cover page were entered on the list of proposals pending as at 1 May 1999 (C4-0219/1999), in respect of which the entry into force of the Amsterdam Treaty entails a change in legal basis and/or legislative procedure (in the case in point, the codecision procedure referred to in Article 251 of the EC Treaty).

By letter of 3 May 1999 the Commission confirmed its initial proposals and submitted them to Parliament.

At the sitting of 3 May 1999 the President of Parliament referred to the Committee on Employment and Social Affairs, as the committee responsible, those proposals pending as at 1 May 1999 which came within its terms of reference.

The Committee on Employment and Social Affairs considered the draft report at its meetings of 1 September 1999.

At that meeting it adopted the draft resolution unanimously.

Commission communication to the European Parliament and the Council – Effects of the entry into force of the Amsterdam Treaty on current legislative procedures (as at 1 May 1999) in the field of employment and social affairs (SEC(1999) 581 – C4-0219/1999)

(Codecision procedure: confirmation of first readings)

The European Parliament,

- having regard to the list of Commission proposals pending as at 1 May 1999, in respect of which the entry into force of the Amsterdam Treaty entails a change in legal basis and/or legislative procedure¹,
- having regard to its resolution of 4 May 1999² on the implications of the entry into force of the Treaty of Amsterdam (list of legislative proposals pending as at 1 May 1999, indicating new legal bases and any changes in legislative procedure following the entry into force of the Treaty of Amsterdam),
- having regard to Article 251(2) , of the EC Treaty,
- having regard to the report of the Committee on Employment and Social Affairs (A5-0006/1999),
